Board Bylaw 9323 states:

With Board consent, the Board president may increase or decrease the time allowed for public presentation, depending on...the number of persons wishing to be heard. The president... may ask that additional persons speak only if they have something new to add."

Therefore, the Board will consider altering the allowed time for individual speakers to three minutes and limit the total time for public input to 45 minutes.
