She also mentioned that the math teachers appreciated attending a seminar last summer giving them time to collaborate and grow.

Mr. Mayben and Stacy Kroeze visited a school that uses the PALs program. They began with a handful of students and the program has grown every year. The program benefits the special education students as well as the mentor students. The general education students would receive appropriate training prior to working with the struggling students.
