Surveys

While parents and students are becoming more aware of our vision and mission through Parent Day visits and our Newsletters, students are experiencing the outcomes within the classroom on a regular basis. The vision is carried out by faculty and staff and is clearly evident in the day-to-day operation of the school and classrooms. Students and their parents are in agreement with the school's vision and mission through evidence gathered by the high levels of satisfaction with the school on Student Surveys and Parent/Guardian Surveys and the high demand for placement at Bird from the comprehensive high school. In addition, Ted Bird High School enjoys support from local partners and businesses who also value the vision and mission of Bird High School. Bird delivers on a vision and mission that drives the educational program at the school. This is done while incorporating the District LCAP goals of improving academic achievement and college/career readiness for all student groups, ensure equitable access for all students to current technology, tools, and instructional strategies to improve educational outcomes and develop a safe, positive culture where all educational partners receive social emotional support; are engaged; and feel safe, heard, and respected.

Classroom Observations

Formal observations and evaluations of certificated personnel are completed following the district employee contract guidelines. Additionally, informal observations are conducted on a daily basis by the site principal.

Analysis of Current Instructional Program

Standards, Assessment, and Accountability

Use of state and local assessments to modify instruction and improve student achievement (ESEA)

Ted Bird courses are standards-based and Board-approved, with the curriculum anchored by Apex online courses supplemented by textbooks. Apex frequently updates its courses, incorporating changes as recent as 2022, which are promptly integrated into our curriculum. Student learning at Ted Bird is assessed through formative and summative evaluations, including the state CAASPP testing. Additionally, college and career activities, including CTE courses at the comprehensive high school, are available to our students, though not all take advantage of these opportunities. Participation in off-campus activities can be improved.

Our counselor is well-connected with local resources, including the food bank, and shares valuable information about scholarships and job listings with students and staff. Traditionally, Ted Bird students come from the comprehensive high school, and articulation between Sonora High and Ted Bird is robust. Ted Bird students can take courses at Sonora High, such as Cosmetology, and apply those credits toward their graduation requirements. Conversely, Sonora High students may attend Ted Bird for part of a semester to meet specific needs, with credits earned at Ted Bird contributing to their Sonora High graduation requirements.

Ted Bird courses feature both formative and summative assessments. Students are tested at each appointment and receive immediate feedback. Work and test grades are recorded on student assignment sheets and shared with both parents and students. Grade sheets, or report cards, are distributed at the end of each semester. Additionally, Renaissance assessments are completed by all Ted Bird students to help identify their levels in reading and math, ensuring that class assessment data is readily available.

Use of data to monitor student progress on curriculum-embedded assessments and modify instruction (EPC)

Many of our courses are sourced from the Apex online program, which allows parents to be added as coaches on their child's courses. This enables them to receive weekly emails detailing their child's progress. Informal meetings between parents and independent study teachers are common and occur naturally, as parents often provide transportation to their child's independent study appointments. Additionally, all campus stakeholders, including teachers, administrators, and the counselor, can easily convene to discuss student progress and strategize on how to best support student success.

The small and intimate setting of Ted Bird fosters an environment of trust, respect, equity, and professionalism among staff. Any differences can be quickly aired and resolved. Regular meetings among teachers, the principal, and staff ensure the sharing of information and opportunities that enhance both teacher development and student progress.

Ted Bird teachers regularly monitor student progress through common assessments in all courses, making individual adjustments as necessary, such as reteaching, modifying homework, or providing one-on-one tutoring. Our teachers remain current with educational practices, continually meeting students where they are to ensure their success.

Staffing and Professional Development

Status of meeting requirements for highly qualified staff (ESEA)

The staff at Ted Bird High School are highly qualified in their respective fields. They feel well-supported in pursuing professional development, knowing that funding is available and that time will be granted for further training. They are encouraged to seek out professional development opportunities that align with the school's vision and purpose. However, despite this open invitation and awareness of available resources, the faculty at Ted Bird utilize professional development opportunities infrequently.

Sufficiency of credentialed teachers and teacher professional development (e.g., access to instructional materials training on SBE-adopted instructional materials) (EPC)

Ted Bird High School teachers are all appropriately credentialed with one exception of a teacher currently pursuing his credential. Each teacher voluntarily chose their assignment at Ted Bird Independent Study and brings significant experience in their respective fields, encompassing education, pedagogy, and classroom routines. The academic counselor is also appropriately credentialed to guide students toward success in high school and beyond.

Although a formal orientation for new assignments is not currently in place, new staff have easy access to experienced teachers for guidance. The principal is approachable, and the school secretary possesses extensive knowledge of the school's procedures, routines, past practices, and traditions. This support network ensures that new staff can quickly acclimate and thrive in their roles.

Alignment of staff development to content standards, assessed student performance, and professional needs (ESEA)

The district, as a whole, has structured professional development around technology use and rigorous curriculum design. Identified needs were then combined with administration observations to compile the following target areas of PD.

- * Rigorous curriculum design for all departments
- * More in-depth Common Core training for English and math as well as curriculum adoption
- * Technology training in all areas of application

Ongoing instructional assistance and support for teachers (e.g., use of content experts and instructional coaches) (EPC)

Instructional support, primarily in math and English, is coordinated through the comprehensive high school through the use of cohorts of teachers working together in pull-out sessions. Additionally, district-level technology experts are working with staff to enhance technological use through instruction.

Teacher collaboration by grade level (kindergarten through grade eight [K–8]) and department (grades nine through twelve) (EPC)

Much of our departmental collaboration occurs with the comprehensive high school. Our district has a late start every Wednesday morning, allowing time for collaboration and training activities. This dedicated time enables various departments to review programs, curriculum, and pacing for numerous programs. It also provides an opportunity to discuss best practices and enhance our programs. Continuous school improvement is a collective effort by the entire Ted Bird High staff, and

the school's intimate setting fosters frequent collaboration among all stakeholders.

Evidence of this collaboration is seen in the growing curriculum files, the robust partnership with the special education department at Sonora High School, and the frequent formal and informal contacts with parents. The faculty at Ted Bird utilizes multiple data sources to assess student needs and evaluate the program's impact on students. These sources include CAASPP testing, attendance records, graduation statistics, and transcripts.

Teaching and Learning

Ted Bird High School provides intervention within our APEX, online curriculum delivery system, with the use of varying levels of instruction capability. APEX allows student access to Prescriptive, Core, Honors, and even AP instruction for higher level needs. This allows the school flexibility to meet the individual students' needs.

Availability of standards-based instructional materials appropriate to all student groups (ESEA)

Ted Bird High School continues to be supported by the district to maintain availability of standards based materials to meet students' needs. Furthermore, our school has worked diligently to get approval of many A-G courses through the APEX System.

Use of SBE-adopted and standards-aligned instructional materials, including intervention materials, and for high school students, access to standards-aligned core courses (EPC)

All courses have sufficient adopted materials that are aligned to their respective content standards, including intervention materials where needed. All students have access to and are enrolled in standard-aligned course consistent with the individual needs. This includes A-G courses.

Opportunity and Equal Educational Access

Services provided by the regular program that enable underperforming students to meet standards (ESEA)

As discussed earlier, the APEX curriculum offers various levels of instruction to individually meet the students' needs. This enables students to meet the standards of instruction and increase educational access. Additionally, the district provides a Title One Aide, counseling support, and special education support when needed.

Evidence-based educational practices to raise student achievement

The district, through the LCAP is supporting increased training for teachers such as Rigorous Curriculum Design (RCD), and provided coaching for mathematics. Also, the APEX and newly adopted math curriculum is researched based on common core standards.

Parental Engagement

Resources available from family, school, district, and community to assist under-achieving students (ESEA)

Under-achieving students receive targeted support through both school and community resources coordinated by the counseling department. Referrals are made as necessary to address individual student needs. Many of our courses are delivered via the Apex online program, which allows parents to be added as coaches on their child's courses. This enables them to receive weekly emails detailing their child's progress. Informal meetings between parents and independent study teachers are common, often occurring naturally as parents provide transportation to their child's appointments.

All campus stakeholders, including teachers, administrators, and the counselor, can easily gather to discuss student progress and strategize on the best ways to support student success. Ted Bird High School also produces a newsletter to keep parents informed about campus events. Additionally, staff hosted a parent night for parents to meet teachers and learn about the program. This year, parents, the principal, teachers, and staff convened at a site council meeting to discuss the school and its initiatives.

Parent and community members are encouraged to participate in the Alternative Education Site Counsel where planning and over-site are discussed. Additionally, parent nights are held annually to encourage more involvement and participation of parents and provide input to the LCAP process. Surveys are conducted annually to further increase involvement of community members.
